Notice Concerning Merger between Consolidated Subsidiaries and Accompanying Change in Trade Name of Consolidated Subsidiary

TODA CORPORATION (the "Company") hereby announces that at the Board of Directors Meeting held on January 31, 2024, the Company has resolved to implement an absorption-type merger (the "Merger"), whereby Toda Staff Service Co., Ltd., a wholly owned subsidiary of the Company, will be the surviving company and Chiyoda Kenkou Co., Ltd. and Green Support Systems Company Limited, also wholly owned subsidiaries of the Company, will be dissolved. The Company has also resolved to change the trade name of Toda Staff Service Co., Ltd., the surviving company, to TGC General Service Company Limited (the "Change in Trade Name") in conjunction with the Merger.

Please note that it is a merger between consolidated subsidiaries of the Company, and that some disclosure items and contents have been omitted.

1. Purpose of Merger and Change in Trade Name

The purpose of the Merger is to increase management efficiency and strengthen the operating framework by reintegrating the businesses of our Group companies and unifying the management and administrative structure.
